**Fire Protection Agreement –  
Town of White City &  
RM of Edenwold**

- 75/10 Kalynchuk/Schwartz:** That:
1. Council direct the Town representatives on the White Butte Regional Planning Steering Committee to formally request that the Committee undertake a formal review of fire protection for the region under the auspices of the Committee; and
  2. Council directs the Administration to negotiate the Fire Protection Services Agreement for the period April 1, 2010 to December 31, 2010 using a remuneration formula based on the Saskatchewan CPI.

**Water Meter Reading  
Revised Process**

- 76/10 Snyder/Schwartz:** That:
1. Council approves in principle, a quarterly billing process that involves one actual meter reading per year in December and three quarterly meter readings provided to the Town Office by residents. Council would reserve final approval of the billing process pending the Administrations evaluation of residents participation in the new billing process and report to Council in January 2011; and
  2. Council authorizes that Administration to negotiate a contract with Synrevoice Technologies Inc. to provide a message delivery system to White City residents.

1. Councillor Kalynchuk reported that the Parks and Recreation Board would be holding their Annual General Meeting on Wednesday April 14, at 7:00pm in the White City School. The Recreation and Cultural Needs Assessment Survey results would be discussed at the meeting also.
2. Councillor Snyder reported that a meeting is being convened with various interested parties to discuss options related to the Lift Station, Gravity Line, Force Main Project. In particular, the matter of the cost of a single lift station to service the project versus the merits of developing two or three smaller lift stations.
3. Councillor Passmore reported that the Library Fund Raiser was very successful they raised approximately \$5,000.

**Bylaw No. 439-05-  
Prohibit the Running at Large of Dogs**

The Town Manager reported that the RCMP were issuing a ticket to a resident for his failure to manage his dogs properly. The resident has two dogs that have been observed running at large throughout the community on several occasions. The dogs have also exhibited menacing behavior towards people and pets. The ticket was accompanied by a Town letter quoting the Bylaw infractions and raising concerns about the potentially dangerous behavior the dogs have been exhibiting.
