Re: Bylaw 544-10; Exchange of Municipal Reserve

### **Background**

Council passed a bylaw to authorize the exchange of municipal reserve in the McKenzie Point Subdivision in November 2010. During review by Community Planning Ralph Leibel, Executive Director, felt that the wording of the first paragraph of the Bylaw is a little confusing.

### **Discussion**

Community Planning is requesting that Council rescind third reading of Bylaw 544-10 and change the wording of the first paragraph as follows:

The original wording of the first paragraph of the Bylaw was:

**“Exchange of Municipal Reserve:** To exchange the municipal reserve area on Parcel B Plan No. 101909189 in the Town of White City from the original plan of survey approved in 2007 shown on the White City Plan of proposed subdivision of Parcel B Plan No. 101909189 to the new plan of survey shown on the attached schedule “A”, which forms part of this Bylaw.”

Proposed new wording:

**“Exchange of Municipal Reserve:** To exchange the municipal reserve area MR1 Plan No. 101909189 Ext 0 for proposed MR1 on plan of proposed subdivision Parcel B and Municipal Reserve MR1 White City, Saskatchewan dated January 27, 2010 prepared by Midwest Surveys.”

Council does not have to re-advertise the Bylaw because the intent of the Bylaw is not changing. The purpose of the change is to clarify the wording.

### **Conclusion**

In order to clarify the wording of Bylaw 544-10, Council must rescind motion 307/10:

**“Slack/Passmore:** THAT Bylaw 544-10 being a Bylaw to Authorize the Exchange of Municipal Reserve be given third and final reading.”
