FCM offering municipal campaign training webinars for women

Berry Vrbanovic, president of the Federation of Canadian Municipalities (FCM) and councillor for the City of Kitchener, Ont., announced a free webinar series aimed at helping women overcome the obstacles they face in running for municipal office.

"The webinars will provide valuable information for women interested in running for municipal office but who have not been able to attend the in-person workshops FCM has been offering across the country for the last two years. They are another contribution to our continued efforts to increase the participation of women in municipal decision-making," said Vrbanovic.

Each of the five English webinars will cover a key campaign issue: campaign finances (November 22, 2011); deciding to run (January 12, 2012); media relations (January 25, 2012); campaign literature (February 7, 2012) and social media (February 14, 2012). A series of French webinars will also be offered.

Webinars are free, but space is limited and participants must pre-register.

Applications for capital projects in the brownfields sector can be submitted at any time before December 1 using the current GMF Application Form. All applicants will need to use an updated form after December 1.

Program updates effective December 1, 2011

To best manage the funding available to support the strongest initiatives, these program updates will take effect on December 1, 2011:

- a new competitive selection process for capital projects in the energy, transportation, waste and water sectors
- updated eligibility criteria and maximum grants for plans, studies and tests
- an updated GMF Application Form and new support tools for applicants

No need to rush: The new selection process for capital projects in the above sectors is designed to enable us to continue accepting new applications year-round and to ensure that the best projects are approved regardless of when the application is submitted.
